We have received one revenue sharing check from MAC and doesn't know if we will be getting another one but its doubtful. We will be discussing our shortfall at the Finance meeting. Superior Aviation has requested a deferment of rent and landing fees for 3 months because of these hard times., and is in agreement that it would be paid by the end of the year.

13. Commissioners' Personal Privilege.

Commissioner Pirlot stated he is concerned about the Senior Center and not being able to get the home delivered meals out that are needed more than ever now.

Commissioner Kramer stated that the home delivered meals for the Seniors are being cooked at North Elementary and it is going very well and we can continue thru the summer if need be. She stated that True North needs to be contacted about their rental services at Lake Antoine. She went to the park and posted pictures of the electrical work being done at the park and has received many positives comments.

Commissioner Stevens stated that it is very good news about the Ski Jumps going forward, it is a good thing for our Community and we can't afford to lose this. He stated he would like Controller Bousley to see about the Counties getting their fair share of the stimulus money and not have it all go to Lansing.

Controller Bousley stated that the bad news concerning the Iron Mountain Senior Center is it is much worse that we thought, so it will take more time and money.

Chairman Wender stated he would like the meetings to go back to having the meetings in the Circuit Courtroom.

It was the consensus of the Board to start having meeting in person again in the Circuit Courtroom.

Commissioners Pirlot and Degenaer are concerned that this will be against Governors Order. Controller Bousley will have to check to see if this is against the stay at home order issued by the Governor.
