4. She stated they advertised twice. She stated there are no qualifications for this position but the Committee felt a strong accounting background would be needed. She stated the Appointment Committee, consisted of Prosecutor Stephanie Brule, Probate Judge Tom Slagle and the County Clerk Dolly Cook.. She stated Lorna was chosen and she has been with the County for 12 years. Cook explained she will have to run for office next year. Cook explained she has worked with Lorna for these twelve years and she has been wonderful to work with and knows the job well. Lorna thanked the Appointment Committee. She stated she loved Dickinson County and she is excited to serve as Treasurer. Chairman Wender welcomed Lorna on behalf of the Board. County Clerk Cook stated she will be sworn in tomorrow at 9:30 A.M. in the Probate Courtroom and everyone was welcome.
