Controller Bousley explained all the things we did in 2017. He stated we have:

Combined Courthouse and grounds and the parks, paved lower parking lot and re-designed it, New Equipment, snow plow, leaf blower and lawnmower, BS&A Software, \$40,000 grant and CUPPAD grant, Collaboration with Iron County and Dickinson for the Friend of the Court, Airport boardings were 18,251 and 35,932 in and out and they created more parking, purchased heavy equipment and some new lighting, Sheriff Department got new medical care at a significant savings, new patrol car and equipment updates, we created a Veteran's Department, settled all union contracts and got rid of the expensive defined benefit, created a security committee, have had active shooter training and the Trane Project is still being worked out.

Bousley explained we will be applying for a loss prevention grant of \$5,000.

13. Commissioners' Personal Privilege.

Commissioner Stevens thanked Tim and staff from the Airport for a job well done! Commissioner Martin stated she wanted to call attention to the mines and the work the Mine Inspector is doing and we need cooperation with the municipalities.

Commissioner Stevens agreed with Martin. He also stated we should remove 7.C. Six County Employment Alliance and replace it with Upward Talent Council.

Commissioner Degenaer Jr., stated he realizes we need the animal shelter but we do nothing for the children in our County and he thinks we should do something.

Chairman Wender stated our goal for 2018 should be to hope the Hospital and Bellin transition goes smoothly and the Community Center is sold to the YMCA.
