Commissioner Martin stated the Board has voted, along with the recommendation of the CEO to issue retention payments to the employees as there is a surplus in Medicaid dollars all across the UP and they can only retain a certain amount, this was due to services down due to the pandemic. This was allocated to maintaining staff, longevity, \$49,000 retention \$4,000 for full time, \$2,000 for part-time, \$1,000 for special part-time, \$2,000 for contract employees. Totals \$858,000, \$105,000. Contract employees. And \$382,000 to MERS defined unfunded liability.

We just got back the prelims on the wage studies, so once we resubmit them and get them back, then we can go into union negotiations.

We received an airport TSA cleaning grant of \$82,000.00 and a \$700.00 VSO training grant thru the State. The airport is in need of about 10 radios, a little over \$20,000.00. The Veterans Grant for \$71,000.00 will be resubmitted, needed a little clean up done on it.

Commissioner Wender stated he would like a motion for the airport radios tonight.
